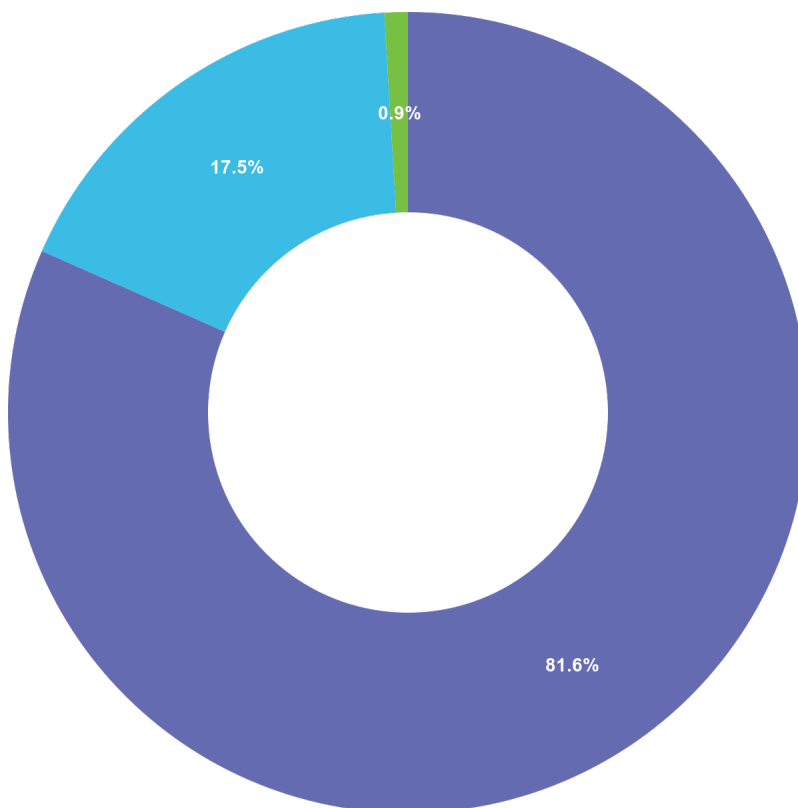

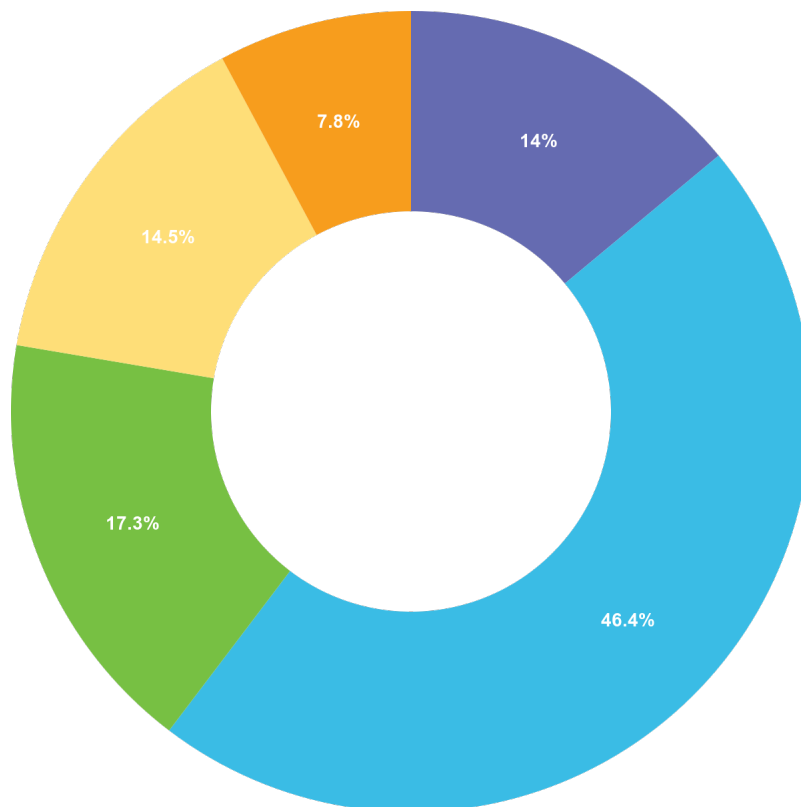
Q1 Are you a Gloucester resident?*

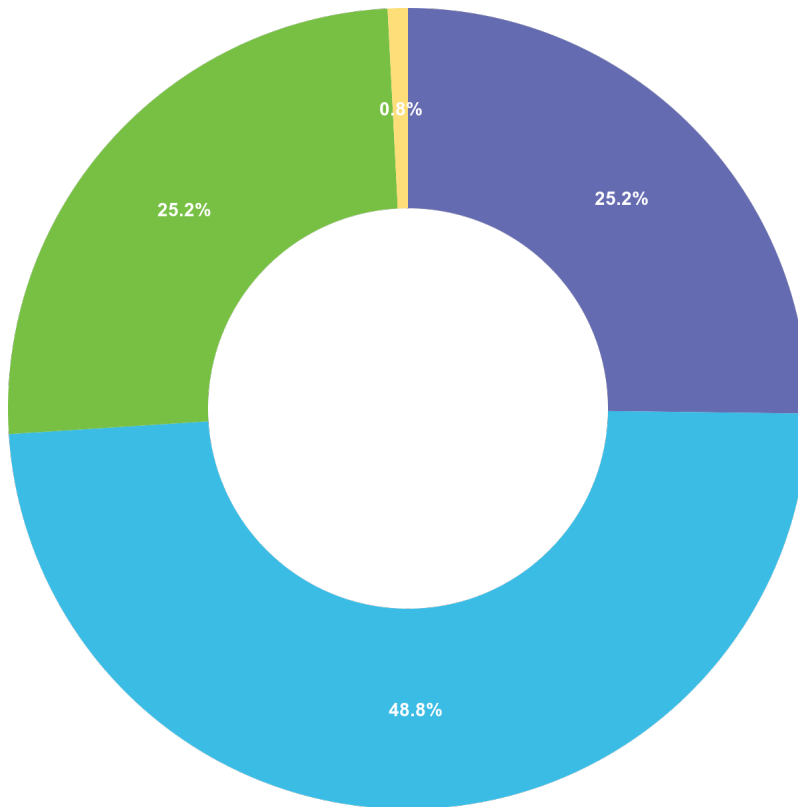
Q2 What is your magisterial district?

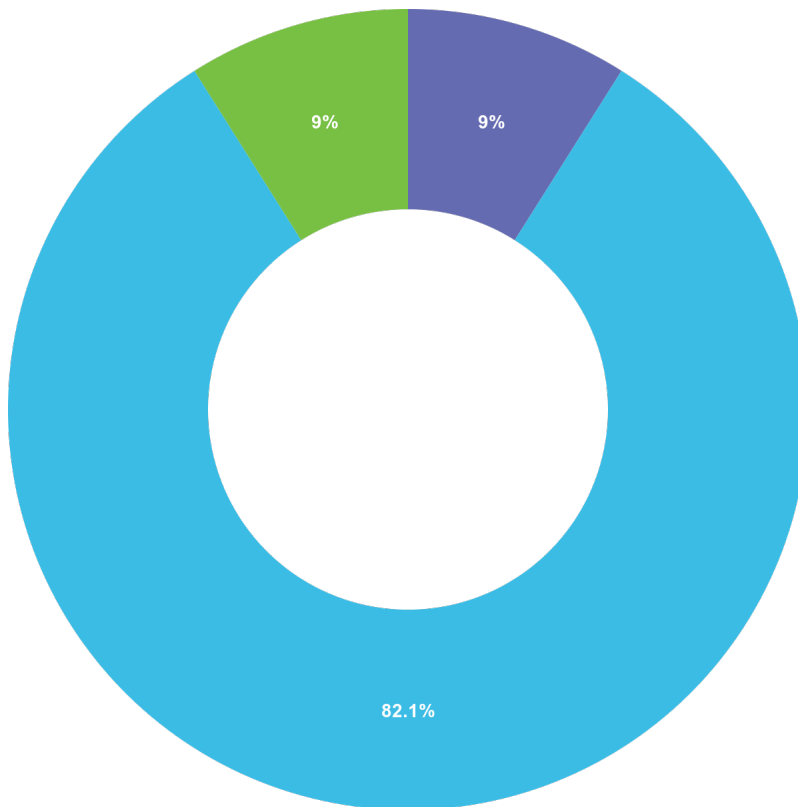
Q3 How did you hear about this meeting?*

Unless the regulations of the district will include requirements that facilities shall have NO MEASUREABLE IMPACT regarding heat discharge, water use and discharge, facility noise, environmental impact on adjacent properties, and air pollution and greenhouse gas emissions, including periodic monitoring and enforcement as necessary, there is too much risk of adverse impact to the

community and environment of the county. I do not believe the county government has the sophistication and expertise to craft strong and clear requirements for such a district. I also do not believe the county has the will, manpower or expertise to monitor compliance over time. A simple internet query will provide numerous examples of issues encountered by similar governments dealing with Data Centers, some with many more resources and capabilities than Gloucester. The concept seems benign, but experience elsewhere has proven it can be extremely complex and problematic.

Failure to implement a sophisticated requirements and monitoring system will expose the county to a risk of continuing harm to the community and expensive protracted litigation to try to correct the conditions. This is a "supersized version" of the Mathews County experience with the "Hole in the Wall Restaurant" debacle. The potential downside of this is immense, and Gloucester County is not ready or able to mitigate that potential.

Establishing a TOD would make it relatively easy for county officials to agree to a data center proposal in Gloucester. Facing financial constraints, I understand that the potential tax revenue from a data center is attractive. Construction of a center would also bring job opportunities during the construction period and a small number of jobs longer term. The presentation about this issue at the community meeting on May 28th gave me the impression that the rapid increase in data centers in other parts of Virginia makes this an inevitability for Gloucester. Really?

In my view, the pro-data center arguments are short-sighted, and far outweighed by the "cons."

- Research by national, state, and local scientific and educational organizations have identified the Middle Peninsula as highly vulnerable to the impacts of climate change. Building a data center will make the problems identified worse, not better. Clean water, clean air, and a pristine landscape are priceless treasures already at risk, and efforts should be made to ensure they remain available.
- As a large area of impermeable industrial built space, a data center or centers would effectively be "irreversible" and would reducing the options available to individual land owners and the county for an indefinite period (once it's there, it can't be undone). Property values would surely suffer.
- A data center would significantly harm the land, flora, and fauna of the area, far beyond the actual footprint of the construction itself. Efforts should be made to enhance, and not destroy, the tangible and intangible benefits of Gloucester's unique environment now and for the future.
- "Moore's Law" (the number of transistors on a chip doubles every two years) sounds outdated today, but the overall trend of increasing computing power and miniaturization remains valid. While predicting the future is impossible, it may be that the data centers being constructed now may not be needed within a decade or less. If that's correct, decisions made that will spoil the beauty of Gloucester will be remembered as huge mistakes.

Gloucester country does not have to jump on the bandwagon of building data centers. If decision makers are not able to reject the idea outright, I hope that they will at least delay any decisions until a later time.

There are so many reasons: (1) Data centers are not consistent with the rural character of northern Gloucester County. They would be a significant negative for residents who live there specifically because of the rural nature of that area. (2) Data centers are huge consumers of electrical power, negating all of the progress we have made so far in trying to decarbonize Virginia's economy, and actually making the situation worse by requiring the construction of new fossil fuel powered generating capacity. This is absolutely the opposite of the direction in which we should urgently be headed. (3) Many of us are skeptical of the claims regarding noise and water-free cooling. I spent a good chunk of my career operating and managing small-scale data centers, and the associated cooling equipment (fans, chillers, etc.) is anything but quiet. There are also concerns about the health impact of low frequency vibrations (infrasound) on nearby residents and animals. (4) Development of the large parcels required for these massive data centers will inherently have a negative impact on the local ecology: wildlife, insects, plants, hydrology, etc. (5) There are no guarantees that the current demand for data centers will continue for two or three decades into the future. Technology is constantly changing, and it could be that these large scale data centers will become obsolete sooner than anyone realizes. In fact, I was reading an article this morning that suggested data centers are being overbuilt, creating a "bubble" that might burst. (6) What becomes of these facilities when their useful life is over, whether through age or obsolescence? Will the county be stuck with a huge abandoned property that gradually falls into decay? (7) Developers have a long history of failing to meet their regulatory obligations (treating the fines for violations as just part of the cost of doing business) and for doing the bare minimum to fulfill (or not) their various proffers. In short, the profusion of these big data centers is wrong for Gloucester, wrong for Virginia, and wrong for the planet. Gloucester County should not be complicit in their proliferation.
