- I. Call to Order and Roll Call Mr. Troy M. Andersen (chairperson) called the meeting to order at 5:30 p.m. Carol Dehoux, clerk called roll with the following members recorded as present: Troy M. - II. **Moment of Silence and Pledge of Allegiance** Mr. Andersen led the board and members in a moment of silence followed by Mr. Drew introducing Aubrey Hudgins (Abingdon E.S.) who led in the Pledge of Allegiance to the flag of the United States of America.
- III. House Resolution No. 283 Delegate Keith Hodges presented retired superintendent, Dr. Walter R. Clemons with a resolution introduced in the Virginia General Assembly recognizing his hard work and efforts during his tenure as superintendent of Gloucester County Public Schools.

<u>Diane Jones (Ware)</u> - Presented Mr. Post with a resolution on behalf of "We The People" of Gloucester County, hopes the "house system" at Petsworth is used in all schools and that Mr. Drew continues his focus on discipline.

<u>Catherine Carter (Abingdon)</u> – Thanked Mr. Post for his service, the public needs to be informed of what occurs in our schools.

<u>Shannon Hansen (York)</u> – Thanked Mr. Post thanked for his service and Dr. Vlad for taking on the challenges in our schools.

Name inaudible (Gloucester Pt.) – Need to stand up to the far left.

<u>Jonathan Hargis (Gloucester Pt.)</u> – Appreciates the service of all four members going off the board, noting ideology is not what is desired by citizens. Need to address the small percentage of students causing the discipline issues and reevaluate the 4 x 4 schedule at GHS.

<u>Mike Rice (Ware)</u> – Spoke proudly of the term his wife Robin just spent as a board member; trust being earned; strength; integrity and the new members who chose to serve at a contentious time.

X. Superintendent's Items – Dr. Vladu

- A. <u>Principal for a Day</u> All School Board and Board of Supervisor members will be invited to serve as a "Principal for a Day" alongside building principals on either February 5th or 6th. A small reception will follow on February 6th at TCWEC. February 26 & 27 will serve as makeup days if needed.
- XI. **Operations Department** *Mr. Bryan Hartley, Director of Operations*
 - A. <u>CIP Update</u> *Charles Records, Construction Manager* indicated the final three water source heat pumps at Peasley M.S. are now expected to be finished over the summer. Phase 1 of the GHS renovations is nearing completion with punch list items and cleaning occurring. The administrative and guidance offices will begin moving over winter break and the counseling modular will be moved. The anticipated final completion date is still September 2025. The budget for GHS renovations was shown and discussion held.

XII. Budget and Finance Items – Ms. Heather Lucas, Chief Financial Officer

A. Financial Report for October 2023 – Ms. Heather Lucas, Chief Financial Officer presented the

October 2023 Financial Report which is available in the packet.

B. <u>Acceptance of Donations</u> – Ms. Lucas read the donations for the month of November totaling \$3,991.00 in monetary donations. Mrs. Rice made a motion to approve the donations as presented. Mr. Post seconded the motion which passed in a unanimous 7/0 roll call vote.

C. Approval of Purchases over \$50k – Ms. Lucas presented a request for approval to purchase access points for the technology department in the amount of \$225,000. Because they are E-rate eligible which reduces the cost by 60%, the division would pay \$90,000 which is already in the budget. Mrs. Rice made a motion to approve which was seconded by Mr. Post and approved in a unanimous 7/0 roll call vote.

XIII. School Board Members' Items – Mr. Andersen

- A. <u>VSBA New Chair/Vice-Chair/Member and Superintendent Orientation</u> Mr. Andersen informed members of the new chair/vice chair, member and superintendent orientation on January 24, 2024 and to please contact Ms. Dehoux by January 9, 2024 to be registered.
- B. Committees/Boards/Commissions Updates from Board Members Mrs. Rice shared that Congressman Rob Wittman toured GHS and the Transportation department on November 20 and on Nov. 27 Delegate Keith Hodges toured Botetourt and GHS. Mrs. Rice and Mr. Burak provided remarks as their terms end and stated it has been a privilege to serve. Mrs. McPherson spoke favorably of the "all in tutoring" program and the careful planning put into the program. She also expressed appreciation for being appointed to the board for this short time and spoke against those who discredit our schools without basis. Mr. Post thanked the citizens of Ware and all who supported him and encouraged incoming members to make GCPS the best regardless of political parties and that it's been an honor and a privilege to serve. Mr. Drew shared the positive experience he recently had with the transportation staff. Ms. Espinoza recognized and thanked outgoing members.
- C. Additional Steps for 3rd Party Investigation Reports Mr. Andersen informed members that discussion on this topic needs to be limited to next steps only. Mrs. Rice moved that the chair be able to issue decision letters on behalf of the School Board that are consistent with the investigator's findings in 2023-SBC01/ 2023-SBC02 /2023-SBC03. Mr. Burak seconded the motion which following brief discussion members approved in a 6/1 roll call vote.

XVI. Grievance Case #230001 – Mr. Burak moved that the school board waive the procedural requirements in personnel grievance matter #230001, consistent with 8 VAC 20-90-50, and authorize the Chair to issue a letter directing the superintendent to submit his recommended personnel action and any other evidence to be considered by the board and directing the employee to submit his rebuttal to the superintendent's recommendation for the school board to consider and render a decision on the record. Mrs. Rice seconded the motion which passed in a 7/0 vote.
