Policy Manual Introduction

Action: <u>Deletion</u>. As advances in technology have provided business, commerce, and educational organizations to transition from "loose-leaf"(paper)-driven to virtual/web-based (paperless)-driven modes of recordkeeping, the Gloucester County School Board Policy Manual no longer maintains policy, regulations and forms on (respectively) white, blue, and pink paper in loose-leaf (three-ring) binders. First adopted in the late-1970's to early 1980's, this historical document served Gloucester County Public Schools well as a framework for the organization of the Policy Manual, but is no longer needed.

School Board Process and Procedure for Presenting Policies, Regulations, and/or Forms for Adoption, Revision, and/or Deletion

Action: <u>Regulation revision</u>. Adopted and revised in 2014, the regulation language has been revised to model current Gloucester County Public Schools policy administration practice and procedure.

Action: <u>Policy revision</u>. Adopted in 2007, and last revised in April 2010, the legal references have been updated to model VSBA policy.
