1. Call to Order and Roll Call

Dr. Anthony Vladu, Superintendent of Schools, Bryan Hartley, Deputy Superintendent, and Charles Records, Construction/Project Coordinator, were also in attendance.

2. Tour of Gloucester High School Renovation

Mr. Records began a tour of the high school renovations outside of the new entrance and noted the new 2,500 square foot addition. The group entered the school through the new security vestibule.

Mr. Records reviewed the work that would be completed during the summer.
